NOTICE OF ORDER HAVING BEEN MADE

THE CITY OF PLYMOUTH (TRAFFIC REGULATION ORDERS) (AMENDMENT ORDER NO. 2019.2137210 PLYMOUTH GATEWAY RETAIL PARK) ORDER 2019

The City of Plymouth (“the Council”) in exercise of its powers under Sections 84 of the Road Traffic Regulation Act 1984 (“the Act”) and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule, have made the above named Orders:-

The effect of the order shall be to add No Waiting at Any Time on the following road: Plymouth Road (Plymouth Gateway Retail Park)

Subject to Schedule 9 Part VI of the Road Traffic Regulation Act 1984, any person wishing to question the validity of the Order or any of the provisions in it on the grounds that the Order is not within the relevant powers or that any of the relevant requirements or regulations made hereunder have not been complied with in relation to the Order, may within six weeks from the date on which the Order is made, make an application for that purpose to the High Court.

Full details are contained in the Order, which, together with the relevant plans, any Orders amended, and a statement of reasons for making the Order may be examined on Mondays to Fridays at First Stop, New George Street in Plymouth.

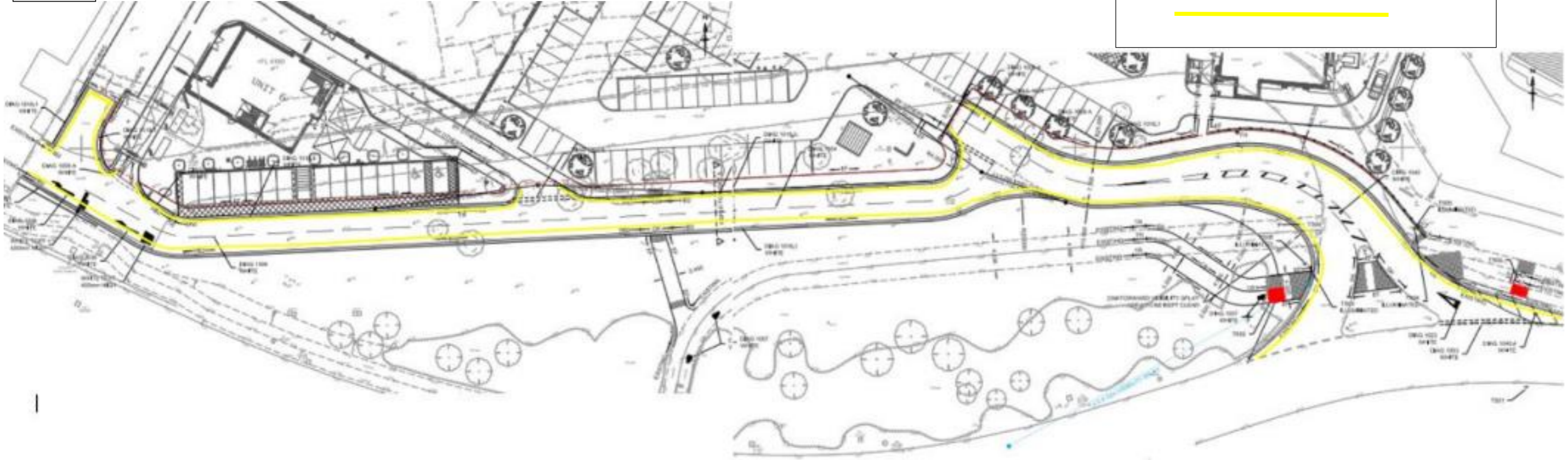
