ALCOHOL CONSUMPTION IN DESIGNATED PUBLIC PLACES (FREEDOM FIELDS)  
ORDER 2011 (NO 6)

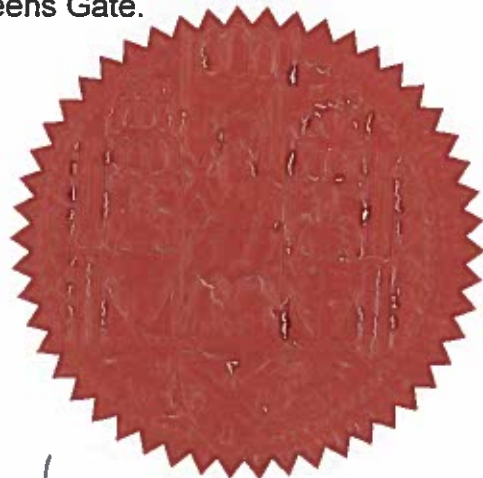
Plymouth City Council (in this Order called "the Council") hereby make the following Order under Section 13(2) of the Criminal Justice and Police Act 2001 (in this Order called 'the Act'):

1. This order may be cited as the 'Plymouth City Council Alcohol Consumption in Designated Public Places (Freedom Fields) Order 2011 (No 6)' and shall take effect on the 1 April 2011.
2. The land within the boundary described in the Schedule below and shown edged in red on the plan attached to this Order, being a public place in the area of the Council which is a public space in which the consumption of alcohol has been associated with disorder, nuisance or annoyance to members of the public or a section of the public is hereby designated for the purposes of Section 13(2) of the Act.

SCHEDULE

Following the boundary starting from the junction of Lipson Road and Queens Gate, heading west into Queens Gate, the boundary line abuts the defined boundaries of all dwellings in Queens Gate, passing over the junction with Queens Gate Villas Road and continues to abut the defined boundaries of the dwellings known as Queens Gate Villas. From this point the boundary line continues south dividing the park and the defined boundaries with Emily Gardens flats, up to the entrance to the park from Greenbank Terrace. From this point the boundary line continues west along Greenbank Terrace. From this point the boundary line continues west along Greenbank Terrace and abuts the defined boundaries of Freedom House and other dwellings up to a point immediately opposite Woodside. From this point the boundary line continues south along Woodside and abuts the defined boundaries of the dwellings on the left hand side of the road until you reach the junction with Lipson Road. From this point the boundary line continues north east along Lipson Road and abuts the junctions with Beatrice Avenue, Chaddlewood Avenue, Seymour Avenue, Pentyre Terrace and the defined boundaries of all dwellings located therein up to a point immediately opposite Queens Gate.
