**ALCOHOL CONSUMPTION IN DESIGNATED PUBLIC PLACES (MUTLEY PLAIN)  
ORDER 2006 (NO.4)**

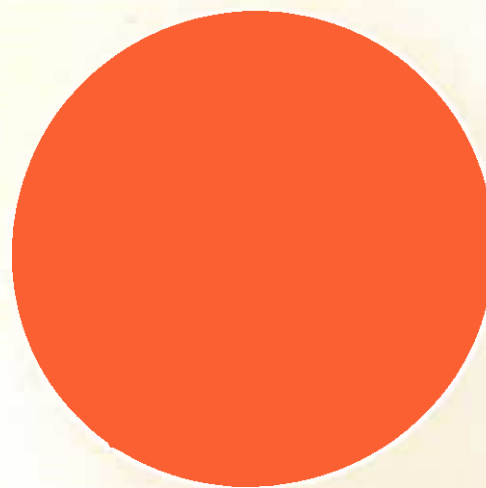
The Plymouth City Council (in this Order called "the Council") hereby make the following Order under Section 13(2) of the Criminal Justice and Police Act 2001 (in this Order called 'the Act'):

1. This order may be cited as the 'Plymouth City Council Alcohol Consumption in Designated Places (Mutley Plain) Order 2006 (no.4)' and shall take effect on the 13<sup>th</sup> November 2006.
2. The land described in the Schedule below and shown edged in red on the map attached to this Order, being land in the area of the Council which is land to which the Criminal Justice and Police Act 2001 applies, is hereby designated for the purposes of the Act.

**SCHEDULE**

Following the boundary starting at the junction of North Hill and Chester Place. Chester Place to its junction with Houndiscombe Road. Houndiscombe Road to its junction with Napier Terrace. Napier Terrace to its junction of Ermington Terrace and Seaton Lane. Seaton Lane to its junction with Ford Park Road. Ford Park Road to the junction with Ford Park Lane. Ford Park Lane to its junction with Hyde Park Road. Hyde Park Road to the junction with Manamead Road. Manamead Road to the junction of College Avenue and back down Manamead Road to the junction of Connaught Avenue. Connaught Avenue to the junction of Mutley Plain Lane. Mutley Plain Lane to its junction with Moorview Terrace. Moorview Terrace (including Moorview Terrace Park) to the junction of Alexandra Road. Alexandra Road to junction with Greenbank Road. Across Greenbank Road junction to North Hill. Across North Hill to its junction with Chester Place.
