CRIMINAL JUSTICE AND POLICE ACT 2001

**ALCOHOL CONSUMPTION IN DESIGNATED PUBLIC PLACES (TOTHILL PARK)
ORDER 2011 (NO 7)**


Plymouth City Council (in this Order called "the Council") hereby make the following Order under Section 13(2) of the Criminal Justice and Police Act 2001 (in this Order called 'the Act'):

1. This order may be cited as the 'Plymouth City Council Alcohol Consumption in Designated Public Places (Tothill Park) Order 2011 (No 7)' and shall take effect on 1 April 2011.
2. The land within the boundary described in the Schedule below and shown edged in red on the plan attached to this Order, being a public place in the area of the Council which is a public space in which the consumption of alcohol has been associated with disorder, nuisance or annoyance to members of the public or a section of the public is hereby designated for the purposes of Section 13(2) of the Act.

SCHEDULE

Following the boundary starting from the tunnel entrance leading to Lucas Terrace, heading east the park abuts defined boundary to the railway line up to where the railway line passes under Lanhydrock Road. From this point the boundary line continues back along Lanhydrock Road and abuts the junctions with Heathfield Road, Mount Gould Crescent, Jephson Road, Farringdon Road, Carmarthen Road and the defined boundaries of all dwellings located therein, up to the junction with Gwyn Road Terrace. From this point the boundary line continues north up Gwyn Road Terrace and abuts the defined boundaries of the dwellings on the right hand side up to a point immediately opposite South View Terrace. From this point the boundary line continues west along South View Terrace and abuts the junctions with Craven Avenue, Maybank Road and the defined boundaries with all dwellings located therein up to a point immediately opposite Egerton Place. From this point the boundary line continues south along Egerton Place where the boundary line abuts Anson Place and Knighton Road and the defined boundaries of all dwellings located therein up to the defined boundary of the railway line. From this point the boundary continues east where the dwellings and the park abut the defined boundary with the railway line up to Lucas Terrace, including the tunnels under the railway line leading to Bulmer Road and Lucas Terrace.
