Notice is hereby given, in accordance with Regulation 19 of the Town and Country Planning (Local Development) (England) Regulations 2012 that Plymouth City Council, South Hams District Council and West Devon Borough Council have produced the Plymouth and South West Devon Joint Local Plan which covers all three local authority areas, but excludes Dartmoor National Park.

a. Title of Document

- i. Plymouth and South West Devon Joint Local Plan, 2014-2034

b. Subject matter

- i. The Plymouth and South West Devon Joint Local Plan provides the overall vision, aims, objectives and spatial policies for the development of the areas covered by Plymouth City Council, South Hams District Council and West Devon Borough Council but excludes Dartmoor National Park. The Plymouth and South West Devon Joint Local Plan sets out the overarching spatial framework for development within the area for the period 2014-2034 and subsequent development plan documents will have to conform to this. It covers the entire district of Plymouth, South Hams and West Devon except for that part which lies within Dartmoor National Park.

c. Period within which representations may be made:

- i. The consultation period for the documents runs from Wednesday 15 March 2017 for six weeks until midnight on Wednesday 26 April 2017.
